PARTICIPANTS ELIGIBILITY

The call is open to everyone - both individuals and groups - adults of any nationality.

RULES FOR PARTICIPATION AND DEADLINES

- To participate one must fill in the attachments A and B, and send them to info@ruraldesignweek.com by **5 May, 2019**.
- If the attachments exceed 20MB, they can be sent via WeTransfer to info@ruraldesignweek.com
- For clarifications on the call, enquires can be sent until **26 April 2019**.
- Notification of the selected works by **13 May 2019**.
- Once the authors have been notified of the selection of their works (13 May 2019), they will receive an invitation to send their contribution by **May the 24th, 2019**. The withdrawal has to be communicated to the organization by May the 19th, 2019.
- The shipping and the installation expenses will be borne by the participant. If the material shipment is too expensive, an alternative exhibition method will be agreed among the parties.
- For each category, the most deserving work will be awarded a prize of €1,500.
- The work will be exhibited - in material and/or paper/digital form - to the public from May 31st to June 9th, 2019.
- Travel, board and lodging expenses will be covered by the organizers only in case the work received a prize or a special mention.
- After June the 9th, the work may be returned to the author at the expense of the author her/himself.
- It is possible to participate in all the event categories.
